A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO 3GX COMPUTERS & IT SOLUTIONS TECHNOSHOP FOR THE SUPPLY & DELIVERY OF DESKTOP COMPUTER AND PRINTER
