A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO RED HOG AGRO INDUSTRIES FOR THE SUPPLY & DELIVERY OF SEEDLING BAGS AND GARDEN NET FOR BUANG NURSERY FARM
