A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO GLAMIEL PHARMA AND MEDICAL SUPPLIES TRADING FOR THE SUPPLY & DELIVERY OF HYGIENE KIT FOR UNDERNOURISHED PRE-SCHOOL CHILDREN IN THE PROMOTION OF SANITATION AND HYGIENE TO LOWER MALNOURISHED
