A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIGHTKEY DEVELOPMENT AND CONSTRUCTION FOR THE SUPPLY & DELIVERY OF HOLLOWBLOCKS MACHINE MOLDER FOR WASTE DIVERSION AT CENTRAL MRF, PRODUCTION OF ECO HOLLOWBLOCKS

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1350** with an Approved Budget for the Contract (ABC) of **Php 80,000.00**;
