A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MAGIC 8 ENTERPRISE FOR THE SUPPLY & DELIVERY OF OFFICE AND OTHER SUPPLIES

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


