A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR THE NUTRITION IN EMERGENCIES AND INFORMATION MANAGEMENT TRAINING FOR BARANGAY NUTRITION COMMITTEE MEMBERS
