A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CPQ COMPUTER CENTER FOR THE SUPPLY & DELIVERY OF LAPTOP AND PRINTER

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1377** with an Approved Budget for the Contract (ABC) of **Php 126,000.00**;
