**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO NAPICO HARDWARE & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE REPAIR/IMPROVEMENT OF WATER UTILITY SYSTEM AT YOUTH HOME**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1381** with an Approved Budget for the Contract (ABC) of **Php 138,248.00**;
