A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CASA VER AMORE INC. FOR THE MEALS & VENUE FOR THE CAPABILITY DEVELOPMENT TRAINING FOR CHILD DEVELOPMENT WORKERS ON THE EARLY INTERVENTION OF PRE-KINDER CHILDREN WITH DISABILITIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1469** with an Approved Budget for the Contract (ABC) of **Php 58,500.00**;
