A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLES FOR THE CONSTRUCTION OF 120LM LINE CANAL AT PUROK 2 BARANGAY PANAL, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1495** with an Approved Budget for the Contract (ABC) of **Php 243,310.00**;
