A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO COTTON CITY MARKETING FOR THE SUPPLY & DELIVERY OF LONGSLEEVES, BURI HAT AND, FACEMASK FOR TUPAD BAYANIHAN 2 WITH 1,246 TUPAD BENEFICIARIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1544** with an Approved Budget for the Contract (ABC) of **Php 373,800.00**;
