A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALN PYROTECHNICS TRADING FOR THE SUPPLY & DELIVERY OF FIREWORKS FOR THE CANDYLAND CHRISTMAS OPENING OF TABACO CITY CHRISTMAS VILLAGE

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1593** with an Approved Budget for the Contract (ABC) of **Php 75,000.00**;
