A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ESSENTRIX CHOICE PHARMA FOR THE SUPPLY & DELIVERY OF MICRONUTRIENT POWDER FOR PROVISION OF MICRONUTRIENT POWDER (MICRONUTRIENT SUPPLEMENTATION)

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1602** with an Approved Budget for the Contract (ABC) of **Php 134,140.00**;
