BAC Resolution No. 2022-3Q-09-0645

A RESOLUTION DECLARING FAILURE OF BIDDING FOR THE SUPPLY & DELIVERY OF CERTIFIED ORGANIC SOIL AMENDMENTS, CITY AGRICULTURE OFFICE, TABACO CITY UNDER CONTRACT ID NO. 019-08-2022-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Certified Organic Soil Amendments, City Agriculture Office, Tabaco City under Contract ID No. 019-08-2022-GOODS* with an Approved Budget for the Contract amounting to *One Million Two Hundred Forty-Nine Thousand Nine Hundred Fifty Pesos (Php 1,249,950.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;


WHEREAS, prior to the deadline for the bid submission and opening on September 05, 2022, the BAC received only one (1) bid, from Peñafrancia Sugar Mill, Inc., Camarines Sur.;

WHEREAS, upon opening and preliminary examination of bids, the BAC found that the bid of the sole participating bidder Peñafrancia Sugar Mill, Inc. failed to submit and comply the requirements of the project particularly the SLCC, Bid Security, Delivery Schedule, Omnibus Sworn Statement and NFCC. Hence, its bid was declared disqualified;

WHEREAS, Section 35.1(c) of the 2016 Revised IRR-RA9184 provides that the BAC shall declare failure of bidding when all bids fail to comply with all the bid requirements;

NOW THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **FAILURE OF BIDDING** for the *Supply & Delivery of Certified Organic Soil Amendments, City Agriculture Office, Tabaco City under Contract ID No. 019-08-2022-GOODS*.




