A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION AND SUPPLY FOR THE SUPPLY & DELIVERY OF COSNTRUCTION MATERIALS AND SUPPLIES FOR THE REHABILITATION/IMPROVEMENT OF PLANETARIUM AT MAYON PLANETARIUM, BRGY. BUANG, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-10-1227** with an Approved Budget for the Contract (ABC) of **Php 553,133.00**;
