### A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF OTHER SUPPLIES

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-10-1251** with an Approved Budget for the Contract (ABC) of **Php 76,581.00**;

**WHEREAS**, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the BAC received five (5) price quotations from suppliers, namely Pandayan Bookshop Inc., Legazpi General Merchandise, KRMKA General Merchandise, 189 Enterprises, & GHG Variety Store;

**WHEREAS**, the opening of price quotations resulted as follows:

**WHEREAS**, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Pandayan Bookshop Inc. was found to be non-compliant for submitting incomplete bid. Hence, its bid was disqualified.


**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, Legazpi General Merchandise. However, it was also found to be non-compliant for failure to indicate the specific brand of all the items offered. Hence, its bid was also disqualified.

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the third lowest quoted price, KRMKA General Merchandise, and it was found to be responsive with the requirements of the project.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To award the contract to **KRMKA GENERAL MERCHANDISE** as the Supplier with the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b) To recommend to the City Mayor of Tabaco the award of contract to **KRMKA GENERAL MERCHANDISE** in the amount of **Seventy-Four Thousand Nine Hundred Ninety-Five Pesos (Php 74,995.00)**.
