A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BRIX CONSTRUCTION AND SUPPLY FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR THE CONSTRUCTION AND INSTALLATION OF SOLAR STREET LIGHTS AT NHA SAN VICENTE, TABACO CITY

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
