A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO REY AUDIO ACTIVE PRO LIGHTS & SOUND FOR THE RENTAL OF LIGHTS AND SOUNDS FOR THE CHRISTMAS CHEERS 2022

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 22-11-1592** with an Approved Budget for the Contract (ABC) of **Php 190,300.00**;
