A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE JOB ORDER: LABOR & MATERIALS FOR THE INSTALLATION OF INTERNET CONNECTION AND NETWORK(COMMUNITY WIFI) AT COMON HIGH SCHOOL AND SAN MIGUEL NATIONAL HIGH SCHOOL, TABACO CITY
