**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GENERAL MERCHANDISE INC. FOR THE SUPPLY & DELIVERY OF SPARE PARTS FOR VEHICLES WITH CONDUCTION STICKER/PLATE NO. SKE-759(GSO), CL-7035 (CHU), SAB-5050 / TCE-02 (CENRO) AND ISUZU VEHICLES (MOTORPOOL)**
