**A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO HYUNDAI ALABANG INC. FOR THE SUPPLY & DELIVERY OF 1-UNIT BRAND NEW AMBULANCE, CDRRMO, TABACO CITY UNDER CONTRACT ID NO. 019-06-2023-GOODS**

**WHEREAS**, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of 1-Unit Brand New Ambulance, CDRRMO, Tabaco City under Contract ID No. 019-06-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Two Hundred Thousand Pesos (Php 2,200,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

**WHEREAS**, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

**WHEREAS**, during the deadline for submission and opening of bids on July 10, 2023, the BAC received one (1) bid proposal;

**WHEREAS**, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:





- b) To recommend to the City Mayor of Tabaco the award of contract to *HYUNDAI ALABANG INC* in the amount of *Two Million One Hundred Eighty-Three Thousand Five Hundred Pesos (Php 2,183,500.00)*.


