A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO 4KMB GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF MATERNAL MILK FOR FEEDING SUPPLEMENTATION OF PREGNANT MOTHERS, CITY NUTRITION OFFICE, TABACO CITY UNDER CONTRACT ID NO. 020-06-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Maternal Milk for Feeding Supplementation of Pregnant Mothers, City Nutrition Office, Tabaco City under Contract ID No. 020-06-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Six Hundred Forty-Four Thousand Seven Hundred Sixty Pesos (Php 644,760.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bid on June 04, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:



- To declare the bid of *4KMB GENERAL MERCHANDISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Maternal Milk for Feeding Supplementation of Pregnant Mothers, City Nutrition Office, Tabaco City under Contract ID No. 020-06-2023-GOODS*; and
- To recommend to the City Mayor of Tabaco the award of contract to *4KMB GENERAL MERCHANDISE* in the amount of *Six Hundred Forty-One Thousand Five Hundred Twenty Pesos (Php 641,520.00)*.




