BAC Resolution No. 2023-3Q-07- 0745

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, CHU & MCK, TABACO CITY UNDER CONTRACT ID NO. 021-06-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, CHU & MCK, Tabaco City under Contract ID No. 021-06-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Eight Hundred Fifty-Four Thousand Four Hundred Thirty-Three Pesos and Fifty-Six Centavos (Php 854,433.56)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) suppliers had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on July 04, 2023, the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

The competing bidder, MGM Medical Supplies & Gen. Mdse. was rated failed at its Technical Component due to non-compliance with the requirements.

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:




WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *BCVR Prime Enterprise*, the bidder with single calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *BCVR Prime Enterprise* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a) To declare the bid of *BCVR PRIME ENTERPRISE* as the Lowest Calculated Responsive Bid (LCRB) for the *Supply & Delivery of Drugs & Medicines, CHU & MCK, Tabaco City under Contract ID No. 021-06-2023-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *BCVR PRIME ENTERPRISE* in the amount of *Five Hundred Seventy-Three Thousand Three Hundred Ninety-Three Pesos and Seventy-Seven Centavos (Php 573,393.77)*.


