**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BEIRICH GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF TABLE & CHAIR**

**WHEREAS**, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-03-0166 with an Approved Budget for the Contract (ABC) of Php 150,000.00

**WHEREAS**, the BAC has posted in the PhilGEPS website the Request for Quotation for this procurement and sent the same to bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:

The line of business is not related to the project and upon validation and inspection of the units offered, the bidder failed to present the items; Hence it was disqualified.

**WHEREAS**, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, Bierich General Merchandise, and it was found to be responsive with the requirements of the project.

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To award the contract to **Bierich General Merchandise** as the Supplier with the the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **Bierich General Merchandise** in the amount of **One Hundred Forty Nine Thousand Five Hundred Pesos [ Php 149,500.00 ]**
