A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JAMESTOWN BUILDERS & CONSTRUCTION SUPPLIES FOR THE JOB ORDER: LABOR & MATERIALS FOR THE IMPROVEMENT OF BASKETBALL COURT AT CITY PLAZA, TABACO CITY
