A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO JS ZAMORA CONSTRUCTION FOR THE JO-LABOR, MATERIALS AND EQUIPMENT FOR THE REPAIR/REHAB OF DRAINAGE SYSTEM AT PUROK 2, PANAL, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-05-0537** with an Approved Budget for the Contract (ABC) of **Php 564,703.00**
