A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO DISTRICT MUSIC CAFÉ DINNER AND CATERING SERVICES FOR MEALS FOR THE LGU NGHT OF TABAK FESTIVAL 2023
