**BIDS AND AWARDS COMMITTEE RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GEN. MDSE. FOR THE SUPPLY & DELIVERY OF MEDICINES AND MEDICAL SUPPLIES TO BE USED AT EVACUATION CENTERS**

**WHEREAS**, the Bids and Awards Committee (BAC) has adopted **Negotiated Procurement (EMERGENCY CASES)** as the mode of procurement for the **Supply & Delivery of Medicines and Medical Supplies to be used at Evacuation Centers** under **Purchase Request No. 23-06-0785 & 0794** with an Approved Budget for the Contract (ABC) amounting to **Php 244,952.75**;

**WHEREAS**, the BAC has directly invited **MGM MEDICAL SUPPLIES AND GEN. MDSE.** to submit a bid proposal for foregoing project;

**WHEREAS**, **MGM MEDICAL SUPPLIES AND GEN. MDSE.** is a supplier with technical, legal and financial capability to supply and deliver the required goods;

**WHEREAS**, **MGM MEDICAL SUPPLIES AND GEN. MDSE.** has submitted its bid proposal and had offered to provide the required goods at a contract price amounting to **Php 229,538.75**;

MDSE.** to supply and deliver the required goods and to address the emergency, the BAC find its offer to be responsive to the requirements of project and the most advantageous price to the government based on the existing price data of the City and Market scanning for the prevailing prices of similar goods;
