A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO KRMKA GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS SUPPLIES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-03-0232 with an Approved Budget for the Contract (ABC) of Php 59,820.00

WHEREAS, after the deadline for submission of price quotations, the BAC received four (4) price quotations from suppliers, namely Powerdeals Tradehaus, KRMKA General Merchandise, 189 Enterprises, & GHG Variety Store;

WHEREAS, the opening of price quotations resulted as follows:

WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, Powerdeals Tradehaus was found to be non-compliant with the requirements of the project. The submitted bid proposal is not an original copy and an item offered is not compliant with the minimum technical specification. Hence its bid was disqualified;

WHEREAS, the BAC proceeded with the examination, validation, and verification of all the documents submitted by the supplier with the second lowest quoted price, KRMKA General Merchandise, and it was found to be responsive with the requirements of the project.

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To award the contract to **KRMKA General Merchandise** as the Supplier with the the Lowest Calculated and Responsive Bid (LCRB) for this procurement.
- b.) To recommend to the City Mayor of Tabaco the award of contract to **KRMKA General Merchandise** in the amount of **Fifty Four Thousand Sixty Eight Pesos** [Php 54,068.00]
