A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO CAR ACCESS AUTO SUPPLY & GEN. MDSE. INC. FOR THE SUPPLY & DELIVERY OF VARIOUS VEHICLE PARTS FOR VEHICLE WITH PLATE NO./CONDUCTION STICKERS SGA-421 (CDU), SJX-677 AND SJH-118 (GSO) AND GENERATOR SET (KOMATSU EGS-45) OF CDU
