A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MMC MARKETING FOR THE SUPPLY & DELIVERY OF CONSTRUCTION MATERIALS AND SUPPLIES FOR REHABILITATION/REPAIR OF PUBLIC CR AT QUINALE, TABACO CITY

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:



WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:
