A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO AMEG CONSTRUCTION & SUPPLY FOR THE CONSTRUCTION / IMPROVEMENT / EXPANSION OF SANITARY LANDFILL (PHASE II), SITIO NAGSIPIT, BRGY. MARIROC, TABACO CITY UNDER CONTRACT ID NO. 032-08-2023-INFRA

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Construction / Improvement / Expansion of Sanitary Landfill (Phase II), Sitio Nagsipit, Brgy. Mariroc, Tabaco City under Contract ID No. 032-08-2023-INFRA*, with an Approved Budget for the Contract (ABC) amounting to *Twenty-Nine Million Two Hundred Thousand Pesos (Php 29,200,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, three (3) contractors had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on September 11, 2023, the BAC received only one (1) bid;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid which resulted to the following, to wit:






- a) To declare the bid of *AMEG Construction & Supply* as the Single Calculated Responsive Bid (SCRB) for the *Construction / Improvement / Expansion of Sanitary Landfill (Phase II), Sitio Nagsipit, Brgy. Mariroc, Tabaco City under Contract ID No. 032-08-2023-INFRA*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *AMEG Construction & Supply* in the amount of *Twenty-Eight Million Nine Hundred Eight Thousand Pesos and One Centavos (Php 28,908,000.01)*.




