WHEREAS, the BAC has directly invited **AYEN GENERAL MERCHANDISE** to submit a bid proposal for the foregoing project;


WHEREAS, **AYEN GENERAL MERCHANDISE** is a supplier with technical, legal and financial capability to supply and deliver the required goods;






