BAC Resolution No. 2023-4Q-10- 1197

A RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO ALBAY COMPUTER & ELECTRONICS SUPPLIES & REPAIR FOR THE SUPPLY & DELIVERY OF DESKTOP COMPUTER SET, CITY VICE MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 036-09-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Desktop Computer Set, City Vice Mayor's Office, Tabaco City under Contract ID No. 036-09-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Two Million Seventy Thousand Pesos (Php 2,070,000.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, two (2) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on October 05, 2023 the BAC received two (2) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:



WHEREAS, the BAC Technical Working Group (TWG) conducted a post-qualification of *Albay Computer & Electronics Supplies & Repair* the bidder with lowest calculated bid, which involves the verification and validation of its legal, technical and financial documents. It was found that *Albay Computer & Electronics Supplies & Repair* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;



- b) To recommend to the City Mayor of Tabaco the award of contract to *Albay Computer & Electronics Supplies & Repair* in the amount of *One Million Three Hundred Sixty-Eight Thousand Seven Hundred Pesos (Php1,368,700.00)*.


