A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO METRO RETAIL STORES GROUP, INC. FOR THE SUPPLY & DELIVERY OF GROCERY ITEMS FOR THE PAMASKONG HANDOG 2023, CITY MAYOR'S OFFICE, TABACO CITY UNDER CONTRACT ID NO. 039-10-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Grocery Items for the Pamaskong Handog 2023, City Mayor's Office, Tabaco City under Contract ID No. 039-10-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *Fourteen Million Six Hundred Eighty-Five Thousand Eight Hundred Eighty Pesos (Php 14,685,880.00)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on November 13, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary "pass/fail" criteria, resulted as follows, to wit:


