A RESOLUTION DECLARING THE SINGLE CALCULATED RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT TO BCVR PRIME ENTERPRISE FOR THE SUPPLY & DELIVERY OF DRUGS & MEDICINES, CITY HEALTH UNIT, TABACO CITY UNDER CONTRACT ID NO. 040-10-2023-GOODS

WHEREAS, the Local Government Unit of Tabaco City posted the Invitation to Bid for the *Supply & Delivery of Drugs & Medicines, City Health Unit, Tabaco City under Contract ID No. 040-10-2023-GOODS*, with an Approved Budget for the Contract (ABC) amounting to *One Million Four Hundred Forty Thousand Four Hundred Twenty-Six Pesos and Twenty-Six Centavos (Php 1,440,426.26)* in the PhilGEPS website, Tabaco City website and in conspicuous places at the premises of the LGU-Tabaco City continuously for seven (7) days;

WHEREAS, in response to the said posting, one (1) supplier had shown interest to participate by purchasing the bidding documents;

WHEREAS, during the deadline for submission and opening of bids on November 20, 2023, the BAC received one (1) bid proposal;

WHEREAS, the opening and preliminary examination of bids, using non-discretionary “pass/fail” criteria, resulted as follows, to wit:

WHEREAS, the BAC immediately conducted the detailed evaluation of bid, which resulted to the following, to wit:





It was found that *BCVR Prime Enterprise* is substantially compliant with the requirements of the foregoing procurement and its bid is responsive;

NOW, THEREFORE, for and in consideration of the foregoing, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare the bid of *BCVR PRIME ENTERPRISE* as the Single Calculated Responsive Bid (SCRB) for the *Supply & Delivery of Drugs & Medicines, City Health Unit, Tabaco City under Contract ID No. 040-10-2023-GOODS*; and
- b) To recommend to the City Mayor of Tabaco the award of contract to *BCVR PRIME ENTERPRISE* in the amount of *One Million Ninety-Seven Thousand Five Hundred Ten Pesos (Php 1,097,510.00)*.
