BAC RESOLUTION RECOMMENDING THE AWARD OF CONTRACT TO FRONTLEARNERS, INC. SUPPLY & DELIVERY OF LEARN KERNEL DEVICE FOR THE LEARNERS IN THE EARLY GRADES NEEDING FULL REFRESHER, SDO-TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) has adopted **Direct Contracting** as the mode of procurement for the **Supply & Delivery of Learn Kernel Device for the Learners in the Early Grades Needing Full Refresher, SDO-Tabaco City** under Purchase Request No. **23-11-1676** with an Approved Budget for the Contract (ABC) amounting to **Nine Hundred Ninety-Nine Thousand Seven Hundred Forty-Seven Pesos (Php 999,747.00)**;

WHEREAS, the BAC directly negotiated the foregoing project with **FRONTLEARNERS, INC.** by requesting the same to submit a price quotation or pro-forma invoice together with the terms and conditions of the sale;

WHEREAS, after the deadline for submission of price quotation, **FRONTLEARNERS, INC.** has offered to supply and deliver the goods at a contract price of **Nine Hundred Ninety-Nine Thousand Seven Hundred Forty-Seven Pesos (Php 999,747.00)**;



DONE this 4th day of December 2023 at the Office of the Bids and Awards Committee, Tabaco City.


