**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ARIZAPA WELDING SHOP FOR THE JO-LABOR, EQUIPMENT RENTAL AND MATERIALS FOR INSTALLATION OF WINDOW SHUTTER AT GOV'T OWNED BUILDING (PHASE 1) AT CITY HEALTH UNIT (CHU) BLDG. 2 (TAYHI, TABACO CITY) & CADAC BLDG. (PAWA, TABACO CITY)**
