A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GEN. MDSE. FOR THE SUPPLY & DELIVERY OF DRUGS AND MEDICINES FOR DISASTER PREPAREDNESS STOCKPILING OF MEDICINES

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-04-0387** with an Approved Budget for the Contract (ABC) of **Php 239,975.08**
