A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION AND SUPPLY FOR THE JO-LABOR, MATERIALS AND EQUIPMENT FOR THE CONTINUATION OF CONCRETING OF BARANGAY ROAD AT PUROK 2 BANGKILINGAN, TABACO CITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-06-0736** with an Approved Budget for the Contract (ABC) of **Php 599,975.00**
