A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES AND GEN. MDSE. FOR THE SUPPLY & DELIVERY OF VARIOUS DRUGS AND MEDICINES FOR MICRONUTRIENT SUPPLEMENTATION AND FOR CITY HEALTH UNIT (CHU) MENTAL HEALTH MEDICAL AND PSYCHOSOCIAL SUPPORT

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt Shopping under Section 52.1 (b) of the IRR-RA 9184 as the mode of procurement for Purchase Request 23-06-0756 & 0759 with an Approved Budget for the Contract (ABC) of Php 339,884.48

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:



WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:
