A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO TABACO SANTIAGO TRADING INC. FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR THE REPAIR AND MAINTENANCE OF CITY MARKET
