A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTION AND SUPPLY FOR THE JO-LABORER, MATERIALS, EQUIPMENT FOR THE FABRICATION OF FURNITURE AND FIXTURE AT CHU BLDG 2 AT QUINALE, TABACO CITY

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:




WHEREAS, upon careful examination, validation and verification of all the documents submitted by the supplier with the lowest quoted price, its bid has been found to be responsive;


