A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO MGM MEDICAL SUPPLIES & GENERAL MERCHANDISE FOR THE SUPPLY & DELIVERY OF VARIOUS MEDICAL SUPPLIES FOR POST-PARTUM BLEEDING AND MATERNAL MORTALITY PREVENTION

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Shopping under Section 52.1 (b)** of the IRR-RA 9184 as the mode of procurement for **Purchase Request No. 23-10-1393** with an Approved Budget for the Contract (ABC) of **Php99,876.53**;

WHEREAS, the BAC has posted in PhilGEPS website the Request for Quotation for this procurement and sent the same bonafide suppliers, indicating the specifications, quantity, ABC and the terms and conditions of the items to be procured;

WHEREAS, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:






