A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO WILLY & SONS CORPORATION FOR THE SUPPLY & DELIVERY OF SPLIT TYPE AIRCON AND WINDOW TYPE AIR-CONDITIONING
