**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO O.R. ROCHA CONSTRUCTIONS AND SUPPLY FOR JO-LABOR & MATERIALS FOR THE PROJECT REHABILITATION OF SAN ROQUE ELEMENTARY SCHOOL AT BRGY. SAN ROQUE ELEMENTARY SCHOOL, TABACO CITY**

**WHEREAS**, after the deadline for submission of price quotations, the return of RFQs sent resulted to the following Price Quotations:


