A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO ASTRIDAIMOND CATERING SERVICES FOR THE MEALS FOR THE CAPABILITY BUILDING ON LEADERSHIP, ORGANIZATIONAL AND MICRO ENTERPRISE DEVELOPMENT, FINANCIAL LITERACY AND BASIC BUSINESS MANAGEMENT TO SLPA

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-10-1453** with an Approved Budget for the Contract (ABC) of **Php 339,600.00**


