**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO BERGONIO GEOMATICS & CONSTRUCTION FOR THE TOPOGRAPHIC & RELOCATION SURVEY AND SUBDIVISION SURVEY**
