**A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO SAN CARLOS HARDWARE OPC FOR THE SUPPLY & DELIVERY OF VARIOUS HARDWARE MATERIALS AND SUPPLIES FOR THE RELOCATION OF WATER LINES AND ACCESSORIES AT CITY ABATTOIR, BRGY. PAWA, TABACO CITY**
