A RESOLUTION RECOMMENDING APPROVAL OF THE AWARD OF CONTRACT TO HOTEL FINA FOR THE MEALS & VENUE FOR THE LEARNING SESSIONS ON SAFE SPACE ACT AND IT'S IMPLEMENTING RULES AND REGULATIONS (IRR) FOR SCHOOL LEARNERS ACTIVITY

WHEREAS, the Bids and Awards Committee (BAC) of the City Government of Tabaco has decided to adopt **Small Value Procurement under Section 53.9** of the IRR-RA 9184 as the mode of procurement for **Purchase Request 23-10-1498** with an Approved Budget for the Contract (ABC) of **Php 77,000.00**
